SPENDING YOUR DOLLARS WISELY

United Way of the Piedmont is the most efficient and effective way to invest in your community. Trained volunteers examine needs, learn about programs, visit nonprofit organizations and determine where your dollars will do the most good. DONOR CHOICE

All gifts share in the administrative cost. To minimize processing costs, a minimum gift of \$25 is required per designated agency. Giving through United Way of the Piedmont ensures that trained volunteers have carefully reviewed where your dollars go. However, if you would like to designate your gift to a particular agency, you may do so. The agency must be eligible to receive tax-exempt donations and must maintain a statement of counterterrorism compliance with our office in keeping with the spirit and intent of the US Patriot Act. If the agency does not qualify, cannot be located or the designation does not meet the minimum gift amount, the pledge will be directed to the Community Impact Fund.
